## WAIVER OF LIABILITY AND INDEMNIFICATION AGREEMENT

This Waiver of Liability and Indemnification Agreement ("Agreement") is made and entered into by and between the undersigned ("Rider") and AZ Riding Academy ("ARA"), its officers, directors, employees, agents, instructors, and affiliates (collectively, "ARA Parties"), in connection with the Rider's participation in any events, training, or riding activities organized or conducted by ARA.

- **1. Acknowledgment of Risk:** The Rider acknowledges and agrees that participation in motorcycle riding, racing, and related activities involves inherent risks, including but not limited to mechanical failure, accidents, loss of control, collisions, and injury. The Rider voluntarily assumes all risks associated with participating in such activities and understands that such risks may result in injury, death, or property damage.
- **2. Release of Liability:** The Rider hereby agrees to release, waive, and discharge AZ Riding Academy, its instructors, agents, employees, affiliates, and all other related entities from any and all claims, demands, or causes of action for injury, death, damage to property, or other losses resulting from participation in any activities, regardless of whether such losses are caused by mechanical failure, the negligence or fault of the ARA Parties, or otherwise.

The Rider agrees that no claim or action will be made against the ARA Parties in connection with any mechanical failure, accident, injury, or damage sustained while participating in any event or activity organized or conducted by ARA.

- **3. Indemnification:** The Rider agrees to indemnify, defend, and hold harmless ARA, its instructors, agents, employees, and affiliates from any and all liability, claims, lawsuits, damages, costs, expenses, and legal fees arising out of or in any way related to the Rider's participation in any event or activity organized or conducted by ARA, including but not limited to any claim related to mechanical failure, accidents, or injuries that occur during the course of such events or activities.
- **4. Mechanical Failures and Accidents:** The Rider acknowledges that mechanical failures of the Rider's motorcycle, or the failure of any equipment used, may occur during the event. The Rider understands and agrees that ARA is not responsible for the condition, maintenance, or failure of the Rider's motorcycle or any equipment used by the Rider during the event.

The Rider further acknowledges and agrees that accidents may occur on the track, regardless of any instruction or oversight provided by ARA instructors, and agrees not to hold ARA or its instructors liable for any accidents that may occur, whether or not caused by the actions of the Rider or others.

- **5. Governing Law:** This Agreement shall be governed by and construed in accordance with the laws of the state in which the event takes place.
- **6. Understanding and Acceptance:** The Rider represents that they are physically and mentally capable of safely participating in the event and that they have read and understood this Waiver of Liability and Indemnification Agreement. The Rider voluntarily agrees to the terms and conditions set forth herein and affirms that they are signing this Agreement freely and knowingly.

By signing below, the Rider acknowledges and agrees to all terms and conditions of this Agreement and accepts full responsibility for any risks associated with participation in ARA events.
